If you are interested in substituting during the 2020-2021 school year for Richards R-V School, you will need to complete (or update for individuals that have already been substituting for us) your personal information online with the Missouri Department of Elementary and Secondary Education at <http://dese.mo.gov> in the substitute certification area as soon as possible (this does not apply to retired teachers).

Missouri United School Insurance Council requires all employees (including substitute teachers) to complete the MUSIC Sexual Misconduct: Staff-to-Student Training. Please visit <http://richards.mo.safeschools.com/login/> and login to access the MUSIC Sexual Misconduct: Staff-to-Student Training which has been assigned to you. See the enclosed MUSIC Training Policy Letter for more information. Please call and I will assign your user name if you are new to our district. Please sign and date this letter stating that you have completed this training. Also enclosed are the "Substitute Teacher Application", "Substitute Teacher Update Sheet", "Cell Phone Policy Letter", and "Form I-9". Please complete and return all of these to me as soon as possible.

Effective January 1, 2005, all individuals hired must have an FBI fingerprint background clearance. Effective July 1, 2012, all applicants will be directed to the Missouri Automated Criminal History Site (MACHS) for this procedure with a cost of \$41.75. You can access their website at www.machs.mo.gov to schedule an appointment online or you may call for an appointment at 844-543-9712. (Applicant Fingerprint Form enclosed with detailed instructions.) If you have previously had the background clearance done, have a current substitute certificate with us and have subbed for us during this past year, you are exempt from having this background check done again. If you have a lifetime teaching certificate on file with us and have subbed for us during the past year, you are exempt from having this background check done. If you apply to sub in multiple districts at one time, this FBI fingerprint background check only has to be done once. However, if you apply in a new district and the current fingerprint background clearance is over twelve months old, then you will have to be fingerprinted and cleared again.

7. Please note your Transaction Control Number (TCN) for future reference.
8. Email and/or phone number, and Date of Birth will be required at the fingerprint vendor location to search for your registration transaction.

The processing fee is automatically calculated based on the 4-digit registration number that was entered at the beginning of registration. All fees are payable to IDEMIA at the time of fingerprinting unless a billing account has been established by your agency.

Once fingerprinting is completed, IDEMIA will transmit your photo, personal data, and fingerprint images to the Missouri State Highway Patrol (MSHP) for processing. The results of the search will be provided to the authorized agency within approximately 1-5 business days. NOTE: IDEMIA does not have access to criminal history. For questions about your results, contact the requesting agency or MSHP. Please reference your TCN.

The Missouri Applicant Fingerprint Privacy Notice includes three (3) parts:

State and Federal Rap Back Privacy Notice

Applicants submitting their fingerprint images to the Central Repository for a fingerprint based criminal record check are advised that their fingerprint images will be retained in state and federal biometrics databases, pursuant to Section 43.540 RSMo. If the submitting agency participates in the State or State and National Rap Back Programs, fingerprint images will be submitted, searched and retained for the purpose of being searched against future submissions to the State and National Rap Back programs; fingerprint searches will also include latent print searches.

The "Missouri Rap Back Program" and "National Rap Back Program" shall include any type of automatic notification made by the State Missouri and/or the Federal Bureau of Investigation through the Missouri State Highway Patrol to a qualified entity indicating that an applicant who is employed, licensed, or otherwise under the purview of the qualified entity has been arrested for a reported criminal offense and the fingerprints for that arrest were forwarded to the Central Repository or the Federal Bureau of Investigation by the arresting agency.

NONCRIMINAL JUSTICE APPLICANT'S PRIVACY RIGHTS

As an applicant who is the subject of a national fingerprint-based criminal history record check for a noncriminal justice purpose (such as an application for employment or a license, an immigration or naturalization matter, security clearance, or adoption), you have certain rights which are discussed below. All notices must be provided to you in writing.¹ These obligations are pursuant to the Privacy Act of 1974, Title 5, United States Code (U.S.C.) Section 552a, and Title 28 Code of Federal Regulations (CFR), 50.12, among other authorities.

- You must be provided an adequate written FBI Privacy Act Statement (dated 2013 or later) when you submit your fingerprints and associated personal information. This Privacy Act Statement must explain the authority for collecting your fingerprints and associated information and whether your fingerprints and associated information will be searched, shared, or retained.²
- You must be advised in writing of the procedures for obtaining a change, correction, or update of your FBI criminal history record as set forth at 28 CFR 16.34.
- You must be provided the opportunity to complete or challenge the accuracy of the information in your FBI criminal history record (if you have such a record).
- If you have a criminal history record, you should be afforded a reasonable amount of time to correct or complete the record (or decline to do so) before the officials deny you the employment, license, or other benefit based on information in the FBI criminal history record.
- If agency policy permits, the officials may provide you with a copy of your FBI criminal history record for review and possible challenge. If agency policy does not permit it to provide you a copy of the record, you may obtain a copy of the record by submitting fingerprints and a fee to the FBI. - If you decide to challenge the accuracy or completeness of your FBI criminal history record, you should send your challenge to the agency that contributed the questioned information to the FBI. Como solicitante sujeto a una indagación nacional de antecedentes criminales basado en huellas dactilares, para un propósito no criminal (tal como una solicitud para empleo o una licencia, un propósito de inmigración o naturalización, autorización de seguridad, o adopción), usted tiene ciertos derechos que se entablan a continuación. Toda notificación se le debe proveer por escrito.¹ Estas obligaciones son de acuerdo al Privacy Act of 1974, Title 5, United States Code (U.S.C.)
